RULES

These rules shall apply to all entrants of the PAPF tournament.

- 1. It is the contestant's responsibility to read, understand and obey all rules of the tournament. Violation of any of these rules can result in disqualification from the current event tournament director's decision.**
- 2. All State, Federal, and Local laws must be obeyed.**
- 3. Any protest must be received in writing with TX numbers and signed within 15 minutes of final check-in deadline to be considered. Tournament Committee decision will be final in all matters.**
- 4. All contestants are required to follow high standards of sportsmanship and courtesy.**
- 5. A U. S. Coast Guard approved PFD must be on and fastened anytime the combustion engine is in gear. All boats must meet U. S. Coast Guard standards. Outboard motors must not exceed boat manufacturing ratings.**
- 6. Official tournament hours and checkpoint will be given at registration and are the responsibility of each contestant.**
- 7. Upon entering this tournament, contestants release PAPF officials, host marina, and sponsors from liability of accidents, losses, or thefts.**

- 8. All fishing must cease as of the designated 3:00 PM stop time.**
- 9. Registration may be by mail (if postmarked on or before August 9th, 2019). Registration other than pre-registration will be Friday August 16th, 2019 from 3PM to 7PM) at the Port Aransas Roberts Point Pavillion. Contact event director, Wayne Williams, p.-806-690-6000, email- wcw4114@gmail.com, for additional information.**
- 10. All fish must be caught in a legal and sporting manner during tournament hours from tournament waters.**
- 11. Fish will be measured on a Pro Rule measuring board with tail pinched closed.**
- 12. Eligibility: PAPF tournament is open to all anglers except professional anglers. A professional angler is defined as someone who has competed in more than one tournament in the last 6 months prior to the event to be entered with an entry fee greater than \$2,500. Fishing guides can be used in the guided division.**

ADDENDUM TO RULES

No tagged or oversize Redfish will be judged.

All fish must be caught on a rod and reel.
